1. **Release** – The Georgia Singers Company (here after referred as the Company) assumes no liability for accidents, injury or loss of property. The person signing on behalf of the student assumes responsibility thereof. The parent or guardian release and authorize the Company use of any photos or video taken during drama activities, including classes for use in advertising, performance programs, brochures or other commercial uses. I hereby authorize the Company to act for me in the event of a serious emergency (requiring medical attention) and I hereby waive and release the Company, its instructors, teachers, and/or directors from any and all liability for injuries and illnesses incurred while in attendance. Furthermore, in the event of an emergency requiring medical attention, the parent or guardian shall pay for all services rendered.
2. **Medical Liability** – The Georgia Singers Company is not liable for any unforeseen medical condition that might arise from participation in the programs at the Peachtree City School of Dance or other locations. The Company reserves the right to request a parent or guardian not to leave a student or immediately come and pick up a student that appears to be in our judgment ill or injured. If the parent or guardian is not available, not able to be reached or not willing to pick up the student, then the Company has the right and duty to call the appropriate services to attend to the student's needs. The parent or guardian is responsible for all payments for any services, medical attention or transportation costs associated with such an event. If other costs are associated with the event that are incurred by the Company, the parent or guardian will reimburse Georgia Singers all costs and reasonable inconvenience associated with this emergency.
3. **No refunds will be made after the first class. CLASS CANCELLATION POLICY (due to uncontrollable circumstances such as bad weather). If we deem it necessary to cancel a class night due to weather conditions or circumstances beyond our control, we will send an email within 2 hours of the class time. REFUNDS WILL NOT BE MADE FOR ANY CLASS NIGHT THAT IS CANCELLED DUE TO BAD WEATHER. We are unable to offer makeup classes based on facility and time restrictions.**
